Financial Year 2025 (July – June) – 11,295 rounds – down (182 players per day, 62 days)

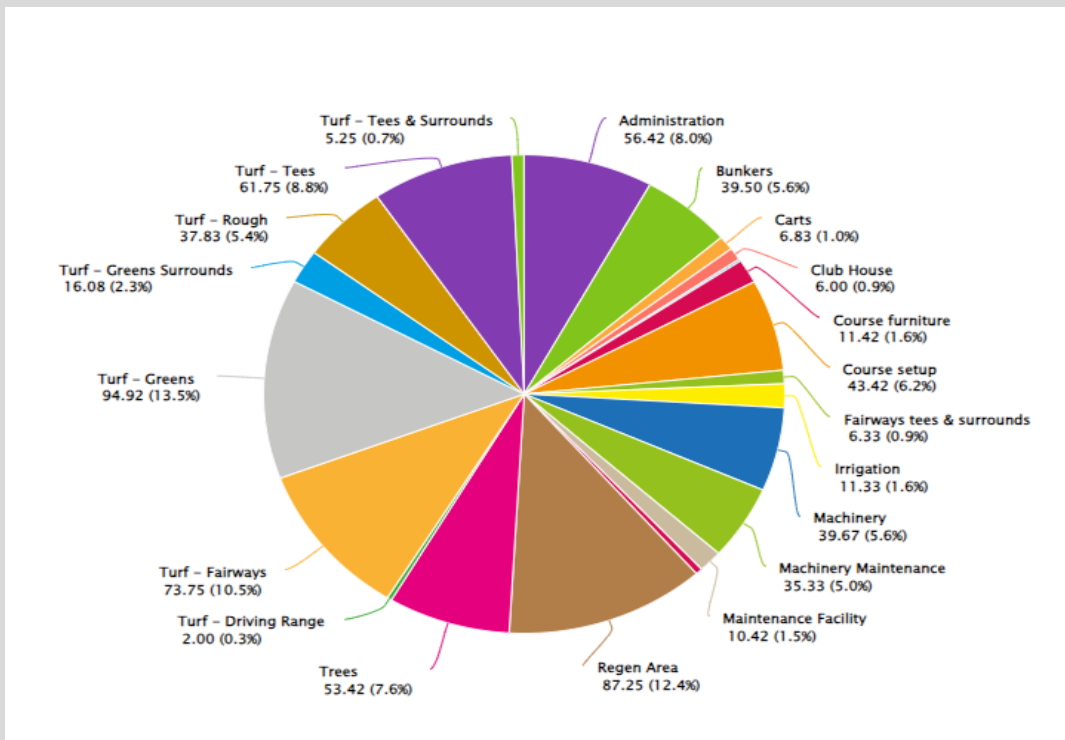
Financial Year 2024 (July - June) – 11,780 rounds – (190 players per day, 62 days)

The Team has been working hard to trim lomandra shrubs around the site to improve visibility across areas of the course. Recent efforts have been at 17th tee and 10th tee.
